**WHEREAS**, the director may also approve the insertion of any item of appropriation for equal amount,

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township White, County of Warren, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2011 in the sum of \$2618.75 which is now available from 'Highlands Plan Conformance Grant Program', State of New Jersey.

**BE IT FURTHER RESOLVED**, that a like sum of \$2618.75 is hereby appropriated under the caption 'Highlands Plan Conformance Grant O/E'.
