RESOLUTION AUTHORIZING RELEASE OF A RESTORATION BOND FOR BRANCH PACKAGING GROUP, INC. (VILLAGE SQUARE)

WHEREAS, by letters dated January 3, 2012 and July 31, 2012, Branch Packaging, Inc., provided notice to White Township requesting that the restoration bond posted with the township be released: and

WHEREAS, in an email dated May 6, 2013 the township engineer authorized release of the restoration bond subject to governing body approval and reimbursement of any escrow deficiency.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of White that the remaining restoration bond posted by Branch Packaging Group, Inc. be released as the project is complete and the township engineer has provided approval.

– yes. Resolution adopted.

WHEREAS, the tax collector has received a 2013 overpayment of \$1,061.44 from Robin & Waymond S Trimmer, property owner of Block 77 Lot 4 known as 3 Piersons Lane; and

WHEREAS, the property owners have requested the overpayment be refunded;

THEREFORE, be it resolved that the Township of White refund Robin & Waymond S. Trimmer PO Box 474 Oxford, NJ 07863 for \$1,061.44.

PUBLIC COMMENTS

Walter Menegus, 96 Hope Crossing Road, requested the committee research preservation options for Block 62, Lot 24, Hope Crossing Road, approximately 78 acres. The property had been previously approved for solar panels by the Board of Adjustment, however, the developer did not follow through on the project. The property is now for sale. The committee authorized the Land Conservancy of NJ to work with the township professionals on this request.

Joseph Bullock, owner of property abutting the township recreation fields, questioned the clean up of the fence row adjoining the properties. He said he felt the debris was pushed back onto his fence and property rather than being taken away or chipped. Mayor Herb said he would look into this situation with the DPW.

OLD BUSINESS

Aaron Cela, representing the Land Conservancy of NJ, was present to provide details on the township's open space applications, including procedures and funding. Mr. Cela explained the process, from application submission to final approval. Mr. Cela also explained the current application, the Ehardt farm, Block 10, Lot 33, Castner Road, approximately 30 acres. The appraisals have been completed and the Ehardt's have signed the contract. The funding for the development rights will be split among the State, County and Township. The township's portion will be approximately \$40,000. Execution of the contract was approved on motion by Mr. Race, seconded by Mrs. Mackey and carried by unanimous favorable roll call vote. Herb – yes, Mackey – yes, Race – yes. Motion carried.

The committee reviewed a request for funding from the Belvidere Town Council. The Council presented amounts spent for fire and rescue services which, in their opinion, exceed the annual donations of both municipalities. The committee will review the request with the auditor.

The committee discussed the DPW generator specifications as prepared by Maser Consulting. Mr. Race suggested two prices be received, one for an automatic switch and one for a manual switch. This was agreed upon and the amended specifications were approved on motion by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable roll call vote. Herb – yes, Mackey – yes, Race – yes. Motion carried.

Mayor and Committee discussed the hours of the zoning office. Mr. Carter was Rice Noticed but opted not to attend the meeting. He had discussed previously with the Mayor that he does not stay for his posted hours when the\ workload does not warrant it. The committee felt that the posted hours must be adhered to for public accessibility. Mr. Carter will be informed of the decision.

CORRESPONDENCE

A letter was received from the NJ Conservation Foundation regarding a preservation opportunity on Scott's Mountain. The committee asked the clerk to invite a representative of the Foundation to the June meeting to discuss the details.
