WHEREAS, T.O 2022-06 provides for annual user fees to be charged to the various residential and commercial users of the sewer system located in White Township; and

WHEREAS, the Warren County (Pequest River) Municipal utilities Authority ("PRUMA") has increased certain wholesale rates for commercial users and otherwise adjusted its 2024 costs, to treat sewage generated within the township based on actual 2023 sewer flows; and

WHEREAS, it is necessary to adjust the user fees charged to properties in White Township generating sewage flows treated at the PRUMA facility in order to pay for the utility's projected 2024 wholesale charges,

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of White that:

- 1. There is hereby imposed for 2024 the following sewer user fees, including the combined 22% administration and maintenance allowance fee as permitted by T.O. 2022-06.

 - b. Brookfield/Brookfield Glen (per dwelling unit): \$641.76 annually; \$160.44 per quarter
 - c. A&P Shopping Center: \$13,029.60 annually; \$3,257.40 per quarter
 - d. Village Square \$702.72 annually; \$175.68 per quarter
 - e. La Torre Pizza \$2,466.84 annually; \$616.71 per quarter
 - f. Brookfield Assisted Living, Block 31 Lot 12.06 \$50,727.60 annually; \$12,681.90 per quarter.
 - g. Augustinian Recollect Ctr, Block 51 Lot 1 \$1,090.68 annually; \$272.67 per quarter
 - h. Belstra, Block 51 Lot 2 \$582.00 annually; \$145.50 per quarter
 - i. Laundromat (Rt 620) \$8,475.36 annually; \$2,118.84 per quarter
