CALL TO ORDER

Mayor Herb updated the committee on a meeting of the Youth Athletic Association he attended. Jess Van Horn had requested use of the ballfields and suggested she was not getting clear answers from the YAA. Mayor Herb said he listened to the YAA's concerns and they came up with formal request procedures for using the fields. The clerk will advise Ms. Van Horn of the procedures.

One application was received for the seasonal DPW laborer. The committee instructed the Road Supervisor to conduct an interview and offer \$15/hour.

NEW BUSINESS

The committee reviewed the CY 2018 Best Practices Checklist. The checklist is provided by the state annually. Each town must answer a series of questions regarding its daily practices. The state then scores the answers. If too many questions are answered negatively, the state may withhold state aid. The clerk reported that White Township received a positive result, therefore, the full amount of state aid will be received in CY 2019.

The Government Records Council complaint will be discussed in Executive Session.

The committee reviewed the liaison positions for CY 2019. No changes are anticipated with Mayor Herb continuing as Buildings and Grounds liaison and Mr. Race continuing as DPW liaison.
