## **CALL TO ORDER**

## **FLAG SALUTE**

The Mayor asked everyone to stand for the flag salute.

## **ROLL CALL**

## **PUBLIC COMMENTS**

Ron Buckenmeyer, 9-1-1 Coordinator, updated the committee on the countywide database update project. Mr. Buckenmeyer completed White Township's evaluation and provided the data to the County. He said one of the biggest problems is numerous residents do not have numbers on their houses, making it difficult for emergency services to locate them. He suggested the township send a reminder in the 2017 tax bill mailing.

### **ENGINEERING UPDATE**

Paul Sterbenz reported on the following:

- The DOT Application for Rutherford Drive will be re-submitted for the 2017 state aid year.
- The Quick Chek project is complete and the company is requesting their performance bond be returned and all escrow monies be refunded. Motion made by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable roll call vote to adopt the following resolution. Herb yes, Mackey yes, Race yes. Resolution adopted.

## Performance Guarantee Release Quick Chek Corporation Lots 4 and 5, Block 62 Route 46, White Township

**WHEREAS**, the Quick Chek Corporation posted performance guarantees in the amount of \$54,024.00 to ensure the satisfactory installation of landscaping and buffer fencing pursuant to site plan and variance approvals granted by the White Township Zoning Board of Adjustment; and

**WHEREAS**, the Quick Chek Corporation has satisfactorily completed all required on-site and offtract site improvement work, including landscaping and buffer fencing; and

**WHEREAS**, the municipal engineer has found that on-site improvements have been installed by the Quick Chek Corporation in accordance with the approved site plan; and

**WHEREAS**, the Quick Chek Corporation has provided a record survey plan that depicts the as-built improvements and which was found to be satisfactory by the municipal engineer; and

**WHEREAS**, the NJDOT has approved all the work that was conducted by the Quick Chek Corporation within the Route 46 right-of-way including the flashing school speed limit signs;

**NOW, THEREFORE, BE IT RESOLVED,** that the Township Committee hereby approves the 11/29/16 request of the Quick Chek Corporation to release the performance guarantee in the amount of \$54,024.00, which includes a performance bond in the amount of \$48,621.60 and cash in the amount of \$5,402.40;

**BE IT FURTHER RESOLVED**, that the release of the performance guarantee is conditioned upon the Quick Chek Corporation providing signed and sealed copies of the approved record survey plan and paying fees and assessments, if any;

**BE IT FURTHER RESOLVED**, that the Township Committee hereby waives the requirement for a two (2) year maintenance bond since all site improvements are privately owned and more than two (2) years has elapsed since the improvements were installed and the store and a gas station began operation.

• Engineer Sterbenz gave the annual stormwater educational presentation. White Township continues to hold its Tier B status, however, the requirements may become more stringent over the next couple of years. Mr. Sterbenz will keep the township informed.

Motion to reject the 2017 4X4 Dump Truck with Spreader and Plow made by Mr. Race, seconded by Mrs. Mackey and carried by unanimous favorable roll call vote. Herb – yes, Mackey – yes, Race – yes. Motion carried. The bid was rejected after consulting with the DPW Supervisor. Mr. Bell indicated he did not need a spreader with this bid. The specifications will be need to be substantially revised.
