## **MINUTES OF MEETING DECEMBER 9, 2020**

### **CALL TO ORDER**

Mayor Herb called the meeting to order at 6:00 p.m. and stated ‘Adequate Notice of this ZOOM meeting of December 9, 2020 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times Warren County Zone; and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee’.

### **FLAG SALUTE**

The Mayor asked everyone to stand for the flag salute.

### **ROLL CALL**

Present: Mayor Herb, Committeewoman Collom, Clerk Kathleen Reinalda and Attorney Tipton. Committeeman Race was absent.

### **PLANET NETWORKS PRESENTATION – Robert Boyle, CEO**

CEO Robert Boyle explained that Planet Networks Inc is a provider of telecommunications services that is authorized by the New Jersey Board of Public Utilities to provide local exchange and interexchange telecommunication services throughout New Jersey. In order to operate they must formally petition the municipality for consent to use the public rights-of-way to place its telecommunication facilities aerially on existing and new utility poles and/or in underground conduits. Planet Networks intends to enter into agreements with the utility companies for the use of their poles. If agreeable, the township must pass a Resolution allowing the Right of Way access. The clerk was asked to prepare the Resolution for the year end meeting.

### **ORDINANCE 2020-08**

### **ORDINANCE TO AMEND PROVISIONS IN CHAPTER 280 OF THE CODE OF THE TOWNSHIP OF WHITE ENTITLED “TRAFFIC REGULATIONS IN SEMIPUBLIC**

**AND PRIVATE AREAS” TO CHANGE THE TITLE OF THIS CHAPTER AND TO  
ADD A SECOND ARTICLE WITHIN CHAPTER 280 CONTAINING TRAFFIC  
REGULATIONS FOR MUNICIPAL STREETS IN THE TOWNSHIP**

**WHEREAS**, Chapter 280 of the Code of the Township of White contains provisions to regulate traffic in semipublic and private areas; and

**WHEREAS**, Chapter 280 of the Code does not have any regulations to regulate traffic on municipal streets in the Township; and

**WHEREAS**, there is a need to amend Chapter 280 at this time to include traffic regulations for municipal streets in the Township due to a September 21, 2020 speed limit investigation performed by Maser Consulting that is recommending the establishment of a 15 MPH speed limit on White Road; and

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of White that Chapter 280 of the Code of the Township of White be amended to read as follows:

**Section 1** - The title of Chapter 280 of the Code of the Township of White shall be revised to read as follows:

“Traffic Regulations in Semipublic and Private Areas and Municipal Streets.”

**Section 2** - Chapter 280 of the Code of the Township of White shall be amended to include a second article as follows:

**Article II  
Municipal Streets**

**§280-14      Speed Limits**

- A.      The speed limits for both directions of traffic along the streets or parts thereof described below and made a part of this chapter, are hereby established at the rate of speed indicated.
  
- B.      Regulatory and warning signs shall be erected and maintained pursuant to the Manual on Uniform Traffic Control Devices (MUTCD) to effectuate the below listed speed limits.

<b>Name of Street</b>	<b>Speed Limit (MPH)</b>	<b>Limit</b>
White Road	15 MPH	Entire Length

**Section 3** - Portions of the Code not set forth above shall remain unchanged.

**Section 4** - This ordinance shall take effect upon adoption by the Township Committee in accordance with the law.

**Section 5** - Any section, subsection or portion of this ordinance that may be found to be invalid by a competent court of jurisdiction shall not invalidate any other section, subsection or portion of this ordinance.

**WHEREAS**, the Committee of the Township of White has developed a comprehensive Farmland Preservation Plan for the Township, which identifies land meeting the criteria for farmland preservation in accordance with the requirements of the State and County's farmland preservation programs; and

**WHEREAS**, the pressures from development continue to pose the threat of imminent change of land use from productive agriculture to nonagricultural uses; and

**WHEREAS**, the State Agricultural Development Committee (SADC) has funding available to assist the Township in acquiring farmland preservation easements, in partnership with the County of Warren via the Municipal Planning Incentive Grant program (Muni-PIG); and

**WHEREAS**, farmland preservation encourages the survivability of agricultural production, the rural character of the Township and the Township's agrarian history; and

**WHEREAS**, the Township Committee has determined that it is in the best interests of the

Township of White to maintain a robust farmland preservation program, to continue to access funds from the SADC's Muni-PIG program, and any other programs that offer funding for farmland preservation, and to acquire as many farmland preservation easements from eligible farms, in partnership with the SADC and the County of Warren, as possible; and

WHEREAS, White Township's Farmland Preservation Committee recommends that the Township continue to participate in the SADC's Muni-PIG Program; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of White, County of Warren, State of New Jersey that it hereby authorizes ongoing participation in the SADC's Municipal Planning Incentive Grant program, as follows:

- 1) The Township approves of the Muni-PIG renewal letter and authorizes the Farmland Preservation Committee and its consultant to submit the renewal application to SADC in advance of the deadline and to continue to work with farmland owners in the Township to develop applications to the programs.

**WHEREAS**, the Warren County Board of Chosen Freeholders of the County of Warren (“Freeholders”) adopted a Resolution whereby it expressed its understanding of the financial destruction that the COVID19/Pandemic has imposed upon local businesses in the County of Warren; and

**WHEREAS**, the Warren County Board of Chosen Freeholders have created an Economic Development Advisory Committee to help foster and encourage opportunities for local businesses; and

**WHEREAS**, the Pandemic and concomitant closure of local restaurants and bars has had a chilling and devastating financial effect upon local business owners and their employees; and

**WHEREAS**, the New Jersey State Alcoholic Beverage Commission has imposed a ten dollar (\$10.00) licensing fee and / or tax additional tax for establishments who will soon be able to serve alcoholic beverages outside their licensed premises within the guidelines for social distancing and Executive Order 150 imposed by the Governor; and

**WHEREAS**, the Freeholders and the Township of White Committee recognize that this additional fee and / or tax creates an additional burden and hardship upon proprietors of establishments which have been closed for ninety (90) or more days; and

**WHEREAS**, the Warren County Board of Chosen Freeholders has expressed its understanding of the concerns of local business owners, its concern for their economic viability, and has determined that available funds to cover this unnecessary excessive fee/tax are available in the account of the Economic Development Advisory Committee; and

**WHEREAS**, the Freeholders will tender payment for this unnecessary fee / tax to the Municipal Clerks of each Warren County municipality for those businesses to serve the public via outdoor dining and consumption of alcohol and in conformance with all Executive Orders from the State.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the

Township of White, in the County of Warren and the State of New Jersey, as follows:

1. The Township of White is authorized to participate in the reimbursement program established by the Warren County Board of Chosen Freeholders.
2. The Clerk is authorized to take whatever steps are necessary to facilitate the purpose of this Resolution and to ensure participation in the reimbursement program to assist local business owners.
3. The Clerk shall provide the Township Committee with an accounting of funds received through the program and funds dispensed to business owners.
4. The Clerk shall serve a certified copy of this Resolution upon the Warren County Board of Chosen Freeholders.

This Resolution shall take effect immediately.

#### **OLD BUSINESS**

Mrs. Collom provided an update on the proposed Property Maintenance Ordinance. She continues to research other towns' ordinances. She suggested she work with Attorney Tipton to tailor an Ordinance specific to White Township.

#### **NEW BUSINESS**

A shared services agreement was presented for ACO services effective January 1, 2021 – December 31, 2021. The agreement mirrors the 2020 agreement with just a change of host location from Washington Township, Warren County to Washington Township, Morris County. Motion made by Mrs. Collom, seconded by Mayor Herb and carried by unanimous favorable roll call vote to authorize the 2021 Agreement for ACO services with Washington Township, Morris County. Collom – yes, Herb – yes, Race – absent. Motion carried.

The 2021 Re-Organization Meeting is scheduled for January 4<sup>th</sup> at 1:00 P.M.

#### **CORRESPONDENCE**

Several property maintenance complaints were received. The committee discussed action that the township could take, which would be very limited, if at all, considering the township does not currently have a property maintenance ordinance. Attorney Tipton advised that some of

the complaints are civil matters between neighbors. Further research will be done on adopting a property maintenance ordinance.

Chris Pozarycki, representing Jack's Barn, explained an issue that arose when he submitted an application to the clerk for a liquor license transfer. The application included licensed areas of the property for which Jack's Barn does not have zoning approval. Mr. Pozarycki explained that his attorney suggested the township consider altering the zone to allow serving of liquor rather than coming back in front of the Board of Adjustment to obtain the necessary approvals. Attorney Tipton said he would research the request.

## **PUBLIC COMMENTS**

Juliet Hyndman, 52 Beechwood Road, suggested the township adopt eco-friendly ordinances.

Danya Bloch, PTO President and Bill Thompson, School Superintendent discussed the new playground being built in 2021. They requested the township consider a donation towards the mulch in its 2021 budget. No action was taken.

**RESOLUTION - EXECUTIVE SESSION**

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and
