Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

## **FLAG SALUTE**

The Mayor asked everyone to stand for the flag salute.

## ROLL CALL

## **PUBLIC COMMENTS**

Sue Reeder, representing the Belvidere Ambulance Corps., provided the committee with a brief update on the rescue squad's activities. She thanked the committee for their financial support.

Mr. Triantafyllos, 6 Good Ole Lane, questioned owing back taxes. He was referred to the tax collector for additional details.

## **2019 BUDGET INTRODUCTION**

Motion made by Mr. Race, seconded by Mrs. Collom and carried by unanimous favorable roll call vote to pass the following Resolution. Herb – yes, Collom – yes, Race – yes. Motion carried.

## RESOLUTION 2019-17 SELF-EXAMINATION OF BUDGET RESOLUTION

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February

## 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of White has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2016 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Township of White that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
  - 4. That pursuant to the Local Budget Law:
    - a. All estimates of revenue are reasonable, accurate and correctly stated,
    - b. Items of appropriation are properly set forth
    - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
  - 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

Motion made by Mr. Race, seconded by Mrs. Collom and carried by unanimous favorable roll call vote to pass the following Ordinance on First Reading. Herb – yes, Collom – yes, Race – yes. Motion carried.

## CALENDAR YEAR 2019 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final

appropriations, subject to certain exceptions; and,

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Township Committee of the Township of White in the County of Warren finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$52,498 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of White, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of White shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$52,498 and that the CY 2019 municipal budget for the Township of White be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Township Auditor, John Mooney presented the 2019 Municipal Budget. The budget contains an increase of three cents largely due to loss of landfill revenues. Motion made by Mr. Race, seconded by Mrs. Collom and carried by unanimous favorable roll call vote to introduce the 2019 Municipal Budget. Herb – yes, Collom – yes, Race – yes. Motion carried. Public Hearing and Adoption is scheduled for April 25, 2019. A complete copy of the 2019 Municipal Budget is on file in the office of the municipal clerk.

# RESOLUTION OF MUNICIPAL SUPPORT FOR THE COUNTY & STATE PURCHASE OF THE DEVELOPMENT EASEMENT ON THE HOFFMAN-LAROCHE FARM BLOCK 46 LOT 37 IN WHITE TOWNSHIP CONSISTING OF APPROXIMATELY 96.54 (3%+) NET ACRES

WHEREAS, the Warren County Agriculture Development Board has determined that the property known as the Hoffman-LaRoche Farm, owned by Hoffman-LaRoche, Inc. located on Block 46 Lot 37 in White Township, consisting of approximately 96.54 (3%+) net acres, has available for purchase a development easement in accordance with the requirements of the farmland preservation program; and

- **WHEREAS**, the pressures from development have significantly heightened the degree of imminence of change of land use from productive agriculture to nonagricultural uses; and
- **WHEREAS,** pursuant to <u>N.J.A.C.</u> 2:76-17.9A(b) on May 16, 2018 it was determined by the State Agriculture Development Committee (SADC) that the application for the sale of a development easement was complete and accurate and satisfied the criteria contained in <u>N.J.A.C.</u> 2:76-17A.9(a); and
- **WHEREAS,** pursuant to <u>N.J.A.C.</u> 2:76-17A.11, on February 28, 2019 the State Agricultural Development Committee has certified a development easement value of \$5,100 per acre based on zoning and environmental regulations in place as of the current valuation date of September 26, 2018 with an estimated total value of \$492,354.00; and
- **WHEREAS,** the property is part of the approved Warren County Planning Incentive Grant Application and is funded by the Warren County Open Space, Farmland, Recreation and Historic Preservation Trust Fund; and
- **WHEREAS**, the tract would encourage the survivability of production agriculture in White Township, and said tract falls within a predetermined County Agricultural Development Area and is in the West Project Area and property is located in the Highlands Planning Area; and
- **WHEREAS**, the purchase of the development easement on the property will encourage the survivability of the productive agriculture in White Township and Warren County; and
- **WHEREAS,** preliminary approval for the purchase of development rights on this farm has been granted by the State Agricultural Development Committee; and
- **WHEREAS,** the SADC is expected to grant final approval for funding amount on said application at its May 23, 2019 meeting; and
- **WHEREAS,** pursuant to <u>N.J.A.C.</u> 2:76-17.13 on March 21, 2019, the Warren County Agriculture Development Board is expected to approve the funding for the development easement with no cost share contribution by White Township as follows: SADC \$333,063, Warren County \$159,291; and

**WHEREAS**, the WCADB approval will include the following conditions:

a. No existing structures on premises

- b. No existing agriculture labor housing on premises
- c. No exception areas
- d. No Residual Dwelling Site Opportunities (RDSO's)
- e. No preexisting non-agricultural uses on premises
- f. General utility easements with access rights and any other TBD with title search
- g. No proposed trails
- h. SADC funding from Base grant, competitive round or both
- i. Warren County is requesting SADC funding for a 3% buffer on the final surveyed acreage

## **NOW THEREFORE BE IT RESOLVED,** by the Township Committee of White as follows:

The Township Committee hereby grants permission for the purchase of the development easement by the County of Warren under the Farmland Preservation Act as set forth above and will not be participating in the cost share.

# AN ORDINANCE APPROPRIATING THE SUM OF \$115,200.00 FROM THE CAPITAL IMPROVEMENT FUND OF THE GENERAL CAPITAL ACCOUNT IN CONNECTION WITH THE COSTS ATTRIBUTABLE TO THE HOPE CROSSING ROAD IMPROVEMENT PROJECT

WHEREAS, the Committee of the Township of White, County of Warren, State of New Jersey, has determined that it needs to appropriate the sum of \$115,200.00 from the Capital Improvement Fund – General Capital Account in conjunction with the Hope Crossing Road Improvement Project; and

WHEREAS, the Committee has been approved for a \$134,800.00 grant from the State of New Jersey for such improvement project, which will be used in addition to the \$115,200.00 to fund the project.

## **NOW THEREFORE BE IT ORDAINED** by the Township Committee of the
