MINUTES OF MEETING MARCH 8, 2018

CALL TO ORDER

Mayor Race called the meeting to order at 7:00 p.m. and stated 'Adequate Notice of this meeting of March 8, 2018 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times and Star-Gazette; and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

FLAG SALUTE

The Mayor asked everyone to stand for the flag salute.

ROLL CALL

Present: Mayor Race, Committeemen Herb and Vande Vrede, Attorney Brian Tipton and Clerk Kathleen Reinalda.

PUBLIC COMMENTS

Sharon Cooper, Titman Road, asked about the status of the Risk Manager position. No action has been taken.

Colleen Williams, Buckhorn Dr., expressed her displeasure over the lack of response to the power outages in the township due to winter storm Riley and Quinn. Emergency Management Coordinator and Township Committeeman Jeff Herb agreed that the township must improve its communications with residents during times of emergency. However, JCP&L has not provided accurate information to the residents or the public officials. Everyone agreed that improved emergency response should be a priority.

Brian Kearns, Youth Athletic Association President gave a brief update on the activities of the association.

WHEREAS, the White Township Tax Assessor received certification from the Department of Veterans Affairs confirming the status of a permanent and totally disabled veteran for the owner of Block 79 Lot 5, at 2 Somerset Drive; and

WHEREAS, the property owner, Roger Deluca, applied for this exemption with the Tax Assessor on 2/26/18; and

WHEREAS, this property will remain exempt from property tax while it remains the principal residence of the permanent and totally disabled veteran; and

WHEREAS, the property owner paid first quarter taxes in the amount of \$1,267.36 and is requesting a refund of \$478.78 which represents taxes overpaid from the date he became eligible for this exemption, 2/26/18.

APPLICATION TO ESTABLISH A CHANGE FUND Township of White, County of Warren

WHEREAS, N.J.S.A. 40A:5-21 authorizes the establishment of a Change Fund in any municipality by resolution; and

WHEREAS, it is desired of the Township of White, County of Warren to establish such fund for the Tax/Sewer Collector in the amount of \$100.00; and

WHEREAS, the custodian for this fund is, Joseph Guerin Jr., who is bonded for the amount of \$1,000,000.00.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of White hereby authorizes the establishment of a Change Fund for Joseph Guerin Jr. in the amount of \$100.00.

NEW BUSINESS

The zoning application for St. Luke's Medical Facility at 189 CR 519 was tabled for discussion in Executive Session.

The township received notice of a grant award from the NJDOT for the overlay of Hope Crossing Road in the amount of \$134,800.00.

The State of New Jersey Agricultural Development Committee is preparing the FY2019 preservation appropriation requests to ensure that new funding is most effectively allocated amongst the many municipalities. Thus, they are requesting from each town a written description of current individual applications pending. The clerk was asked to forward the letter to the Open Space Committee.

Motion made by Mr. Vande Vrede , seconded by Mayor Race with Mr. Herb abstaining to approve the renewal of the open space advisor contract with the Land Conservancy of NJ for the term April 1, 2018 – March 31, 2019 at \$100 per hour and mileage. Herb – abstain, Vande Vrede – yes, Race – yes. Motion carried.

PUBLIC COMMENTS

Bud Allen, 2 Brookfield Dr., questioned the address for the St. Luke's Facility (old Country View Village Strip Mall). The zoning officer had indicated in a letter that it was 187-189 CR 519. The clerk will research the correct address of record.

CORRESPONDENCE

Knowlton Township requested the committee's support in opposition of the NJDOT's 'Rock Mitigation Project' along Route 80 and through the Delaware Water Gap. A Resolution of opposition was provided by Knowlton. The governing body felt that they did not have enough information on the subject to take a position.

A letter was received from the NJ Highlands Council reminding municipalities that any application for development located in the Preservation Area shall be forwarded to the Highlands Council at least 10 days prior to the public hearing date.

Bud Allen, 2 Brookfield Dr., made a few remarks regarding NJ's possible legalization of marijuana and what he felt would be the impact to White Township.
