### MINUTES OF MEETING MARCH 9, 2017

#### **CALL TO ORDER**

Mayor Race called the meeting to order at 7:00 p.m. and stated 'Adequate Notice of this meeting of March 9, 2017 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times and Star-Gazette; and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

#### **FLAG SALUTE**

The Mayor asked everyone to stand for the flag salute.

#### ROLL CALL

Present: Mayor Race, Committeeman Herb, Committeewoman Mackey, Attorney Kathryn Fina and Clerk Kathleen Reinalda.

#### **PUBLIC COMMENTS**

Lynsey Klejna, 34 Titman Road, expressed her displeasure with the condition of Five Acres Flea Market and what she perceives as a lack of zoning enforcement. The zoning officer issued a letter indicating no violations exist other than placement of sheds. The neighboring property owner's concerns go far beyond that, including buffer requirements, lighting and operating hours. The clerk advised that, by law, the neighbors have a twenty day appeal period from the date of the zoning officer's letter. They can appeal the zoning officer's decision to the Board of Adjustment.

Joseph Nunes, Belvidere Ambulance Corps, presented the idea of a paid daytime staff. He explained that they are struggling to get volunteers during working hours, 6am to 6pm. By going to a paid staff, this could attract more membership and better service. The staff would be paid by billing the resident's insurance companies. Hardships would be written off. Mayor Race suggested Mr. Nunes put a proposal together for the committee to review.

WHEREAS, the Township Committee of the Township of White has determined that a gypsy moth control program should be instituted with the State of New Jersey Department of Agriculture and that application for any Federal or State funds available be authorized.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of White that the gypsy moth is declared to be a public nuisance and the protection of vegetation or plant life therefrom is deemed to be a subject matter of public welfare, and that all measures deemed necessary, in compliance with the State of New Jersey Department of Agriculture recommendations, is hereby authorized to suppress this forest and shade tree pest.
