CALL TO ORDER

Mayor Race called the meeting to order at 7:00 p.m. and stated 'Adequate Notice of this meeting of April 12, 2018 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times and Star-Gazette; and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

FLAG SALUTE

The Mayor asked everyone to stand for the flag salute.

ROLL CALL

Present: Mayor Race, Committeemen Herb and Vande Vrede, Attorney Katherine Fina and Clerk Kathleen Reinalda.

PUBLIC COMMENTS

Linda Stettler, National Night Out Coordinator for the Town of Belvidere, requested the committee consider a donation to the August 7th event.

Keith Wolfinger, Goodwill Fire Company Chief, and Faith McEvoy, member of the Belvidere Ambulance Corp., introduced themselves to the committee and the public. They gave some recent statistics on calls, membership, etc. The purchase of the new fire truck is on schedule.

2018 MUNICIPAL BUDGET INTRODUCTION

Motion made by Mr. Herb, seconded by Mr. Vande Vrede and carried by unanimous favorable roll call vote to approve the following ordinance on first reading. Public Hearing will be scheduled for May 24^{th} Herb – yes, Vande Vrede – yes, Race – yes.

CALENDAR YEAR 2018 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final

appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of White in the County of Warren finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$49,418 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of White, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Township of White shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$49,418 and that the CY 2018 municipal budget for the Township of White be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Motion made by Mr. Vande Vrede, seconded by Mr. Herb and carried by unanimous favorable roll call vote to approve the following Resolution. Herb – yes, Vande Vrede – yes, Race – yes. Resolution passed.

Resolution 2018 -23

WHEREAS, the Township of White, County of Warren realized 92.85% of current tax collections for the year 2017, and

WHEREAS, the tax collection percentage was adversely impacted by tax appeals, and

WHEREAS, the percentage of cash collections on current taxes for the three prior years was as follows:

AND WHEREAS the Mayor and Council believe the tax collections for the year 2018 will improve over the year 2017.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee that permission be requested by the Director of the Division of Local Services to permit the Township to anticipate a current tax collection percentage experience of 95.15% for the year ended December 31, 2018.

RESOLUTION # 2018-24

DEFERRED LOCAL DISTRICT SCHOOL TAX

WHEREAS, the local district school tax for the fiscal year July 1, 2017 to June 30, 2018 was raised in the 2017 tax levy in the amount of \$7,343,122, and

WHEREAS, the statutes permit the deferral of the cash liability of such school tax up to 50% of the school tax levy or \$3,671,561.00;

NOW, THEREFORE BE IT RESOLVED by the Mayor and Committee of the Township of White, that the deferred school tax for the local school district be increased from \$3,360,132.35 to \$3,486,596.88 as of December 31, 2017; and

BE IT FURTHER RESOLVED that two certified copies of this resolution be filed with the Director of the Division of Local Government Services.

2018 MUNICIPAL BUDGET INTRODUCTION

The 2018 Budget includes a 2 cent increase making the municipal levy a total of seven (7) cents. This is an approximate \$56 annual increase to a home assessed at \$258,674.00. Motion made by Mr. Vande Vrede, seconded by Mr. Herb and carried by unanimous favorable roll call vote to approve the 2018 Municipal Budget on first reading. Public Hearing will be scheduled for May 24th. Herb – yes, Vande Vrede – yes, Race – yes. The 2018 Introduced Municipal Budget is on file in the Office of the Municipal Clerk.

ORDINANCE AMENDING ARTICLE XX OF THE LAND USE ORDINANCE ENTITLED "N-C NEIGHBORHOOD COMMERCIAL DISTRICT" TO ALLOW MEDICAL AND HEALTH SERVICE USES AS PRIMARY INTENDED USES IN THE N-C NEIGHBORHOOD COMMERCIAL DISTRICT

WHEREAS, a variety of retail and office uses are permitted in the Township's N-C Neighborhood Commercial District ("N-C"); and

WHEREAS, the primary intended uses in the N-C District are enumerated in Section 160-160 of the Land Use Ordinance; and

WHEREAS, the list of primary intended uses does not include medical and health service uses; and

WHERAS, medical and health service uses would typically be a primary intended use in a zone such as the Township's N-C District; and

WHEREAS, the Township would like to amend the Land Use Ordinance to allow medical and health service uses as primary intended uses in the N-C District.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of White as follows:

- <u>Section 1</u> Section 160-160A of the Code of the Township of White shall be amended to add the following:
- (13) Medical and health services, excluding veterinarian services.
- Section 2 Portions of the Code not set forth above shall remain unchanged.
- <u>Section 3</u> This ordinance shall take effect upon adoption by the Township Committee in accordance with the law,

<u>Section 4</u> - Any section, subsection or portion of this ordinance that may be found to be invalid by a competent court of jurisdiction shall not invalidate any other section, subsection or portion of this ordinance.

Ord. 2018-02: Motion made by Mr. Vande Vrede, seconded by Mr. Herb and carried by unanimous favorable roll call vote to approve the following ordinance on First Reading. Public Hearing is scheduled for May 24th. Herb – yes, Vande Vrede – yes, Race – yes. Motion carried.

AN ORDINANCE APPROPRIATING THE SUM OF \$85,000.00 FROM THE CAPITAL IMPROVEMENT FUND OF THE GENERAL CAPITAL ACCOUNT IN CONNECTION WITH THE COSTS ATTRIBUTABLE TO THE RUTHERFORD DRIVE IMPROVEMENT PROJECT

WHEREAS, the Committee of the Township of White, County of Warren, State of New Jersey, has determined that it needs to appropriate the sum of \$85,000.00 from the Capital Improvement Fund – General Capital Account in conjunction with the Rutherford Drive Improvement Project; and

WHEREAS, the Committee has been approved for a \$125,000.00 grant from the State of New Jersey for such improvement project, which will be used in addition to the \$85,000.00 to fund the project.

NOW THEREFORE BE IT ORDAINED by the Township Committee of the Township of White, County of Warren and State of New Jersey that:

- 1. There are funds available in the Capital Improvement Fund of the General Capital Account in the Municipal Budget of the Township of White for costs attributable to the paving projects.
- 2. There is hereby appropriated the sum of up to \$85,000.00 from the Capital Improvement Fund of the General Capital Account in the Municipal Budget of the Township of White for the aforementioned purpose.
- 3. There is no debt authorized by this Ordinance.
- 4. This Ordinance shall take effect upon passage following a public hearing to be conducted thereon and publication of notice of final passage with the requirements of law.

OLD BUSINESS

Mayor Race asked the committee the status of scheduling a special meeting to interview risk managers. Mr. Herb maintained that he has not supported changing risk managers since Mayor Race brought it up. Mr. Vande Vrede said after further review he is not comfortable switching risk managers at this time.

NEW BUSINESS

The township received a proposed shared services agreement from Washington Township, Warren County for maintenance of an animal control vehicle along with mileage. The committee requested the Animal Control Officer come to a meeting to discuss the proposed agreement.

PUBLIC COMMENTS

None.

CORRESPONDENCE

A complaint was received from 210 Buckhorn Dr., Mr. and Mrs. Simoes, regarding a drainage situation from a neighboring property. The letter indicates that the drainage ultimately ends up running across Buckhorn Dr. The DPW will be asked to review the situation and take any necessary action, if need be.

An invitation was received from the 24th Legislative District for a Town Hall Meeting April 20th at the Frelinghuysen Municipal Building.

The committee regretfully accepted plumbing inspector Duane Cowley's resignation. The current Construction Official, Ralph Price, possesses the necessary license to perform the duties of a plumbing inspector. The committee agreed that Mr. Price will assume those duties into his current schedule for the same salary as Mr. Cowley was receiving.
