MINUTES OF MEETING APRIL 14, 2016

CALL TO ORDER

Mayor Herb called the meeting to order at 7:00 p.m. and stated 'Adequate Notice of this meeting of April 14, 2016 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times and Star-Gazette; and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

FLAG SALUTE

The Mayor asked everyone to stand for the flag salute.

ROLL CALL

Present: Mayor Herb, Committeeman Race, Committeewoman Mackey, Attorney Katherine Fina and Clerk Kathleen Reinalda.

ENGINEERING UPDATE

BJ Wauhop of the Warren County Municipal Utilities Authority discussed options for the sewer meter project on Water Street. After extensive research, Mr. Wauhop questioned the effectiveness of a meter due to pipe size restrictions. Also, very limited flow is anticipated which makes the notion of a meter impractical. He suggested the committee consider 'float readings' from the box currently located at the A&P. The MUA would be responsible for the readings. The other users on the line, the Belstra's and the Augustinians, are currently being billed by the MUA based on EDU's. This will continue. The committee reminded Mr. Wauhop that the Town of Belvidere originally felt that metering would be the best solution as it was perceived that White Township was not paying its fair share of flow through the Town of Belvidere line. Mr. Wauhop suggested he present his idea to the Town of Belvidere and see if perceptions had changed over the last two years. Mayor Herb noted that White Township has paid its fair share over the years and by not metering the line, Belvidere will actually receive more money due to the fact that there is very little flow through the line.

2016 BUDGET INTRODUCTION

Auditor John Mooney was present to introduce the 2016 Municipal Budget. The 2016 Municipal Budget includes a 2 cent decrease from 2015.

Motion made by Mr. Race, seconded by Mrs. Mackey and carried by unanimous

favorable roll call vote to approve the following Resolution. Herb – yes, Mackey – yes, Race – yes. Motion carried.

SELF-EXAMINATION OF BUDGET RESOLUTION [as required by DCA]

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of White has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2016 budget year.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Township of White that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-5.
- 4. That the pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth

- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

Motion made by Mr. Race, seconded by Mrs. Mackey and carried by unanimous favorable roll call vote to approve the following ordinance on first reading. Herb – yes, Mackey – yes, Race – yes. Motion carried.

CALENDAR YEAR 2016 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40a:4-45.154)

WHEREAS, the Local Government Cap Law, N.J.S.A.40A:4-45.1 et. seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 0.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee of the Township of White in the County of Warren finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$47,429 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Township Committee hereby determine that any amount

authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of White, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Township of White shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$47,429 and that the CY 2016 municipal budget for the Township of White be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Motion to introduce the 2016 Municipal Budget made by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable vote. Herb – yes, Mackey – yes, Race – yes. A complete copy of the 2016 Municipal Budget is on file in the office of the municipal clerk. Public Hearing is scheduled for May 12th at 7PM.

RESOLUTION OF AWARD OF CONTRACT MUNICIPAL BUILDING EMERGENCY GENERATOR INSTALLATION

WHEREAS, the Township of White ("Township") seeks to install an emergency generator at the Municipal building to provide an auxiliary power source during times of emergency; and

WHEREAS, the Township prepared construction plans, technical specifications, and bid documents for the project; and

WHEREAS, the Township advertised the project for public bids; and

WHEREAS, the Township received and opened bids for the project on Friday, March 11, 2016; and

WHEREAS, bids were received from five contractors; and

WHEREAS, the lowest bid was submitted by Lulo Electric of Hackettstown, New Jersey; and

WHEREAS, the amount bid by Lulo Electric for the work specified by the Township is \$53,015.00; and

WHEREAS, the low bidder was contacted by the municipal engineer for the purpose of reviewing the bid; and

WHEREAS, the municipal engineer determined during the review of the Lulo Electric bid that the bid was predicated on providing a generator that does not meet the project specifications; and

WHEREAS, Lulo Electric subsequently requested that its bid be disqualified for not providing a generator that is in compliance with the specifications; and

WHEREAS, the second lowest bid was submitted by Wire's Electrical Shop ("Wires") of Hackettstown, New Jersey; and

WHEREAS, the amount of the Wires bid was \$58,240.00, which is less than the engineer's estimate of \$65,000.00; and

WHEREAS, the bid submitted by Wires is based upon the furnishing of a Kohler generator in accordance with the project specifications pursuant to a bid review conducted by the municipal engineer; and

WHEREAS, Wires is a qualified contractor and no prior negative experience as defined in the Local Public Contracts Law was found by the municipal engineer during his bid review; and

WHEREAS, Wires is thus the lowest responsible bidder;

NOW THEREFORE BE IT RESOLVED, that the Township Committee of the Township of White hereby awards a contract to Wires for the installation of an emergency generator at the White Township Municipal Building in the amount of \$58, 240.00 subject to legal review and the availability of funds.

BE IT FURTHER RESOLVED, that copies of this resolution shall be forwarded to Wires and the municipal engineer following adoption.

RESOLUTION AUTHORIZING REFUND OF PREMIUM TO OUTSIDE LIENHOLDER

WHEREAS, the Municipal Tax Sale held on October 16, 2013, a lien was sold on Block 16 Lot 13 also known as 652 Brass Castle Road for 2012 delinquent taxes; and

WHEREAS, this lien, known as Tax Sale Certificate No. 2013-003 was sold to US Bank Cust for Pro Cap III, LLC for a 0% redemption fee and a \$1,000.00 premium.

NOW THEREFORE, BE IT RESOLVED, that the Treasurer be authorized to issue a check in the amount of \$1,000.00 (premium account) payable to US Bank Cust for Pro Cap III, LLC 50 S. 16th St STE 1950 Philadelphia, Pa 19102 because the lien was redeemed.

2015 TONNAGE GRANT APPLICATION RESOLUTION

- **WHEREAS,** The Mandatory Source Separation and Recycling Act, P.L.1987, c.102, has established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and
- WHEREAS, It is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and
- **WHEREAS,** The New Jersey Department of Environmental Protection has promulgated recycling regulations to Implement the Mandatory Source Separation and Recycling Act; and
- **WHEREAS,** The recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and
- WHEREAS, A resolution authorizing this municipality to apply for the 2015 Recycling

 Tonnage Grant will memorialize the commitment of this municipality to
 recycling and to indicate the assent of the White Township Committee to the
 efforts undertaken by the municipality and the requirements contained in the
 Recycling Act and recycling regulations; and
- **WHEREAS,** Such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

NOW THEREFORE BE IT RESOLVED by the Township Committee of The Township of White that The Township of White hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates Linda Gabel to ensure that the application is properly filed; and

BE IT FURTHER RESOLVED that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.

OLD BUSINESS

Frank Panetta presented a signed petition in support of re-naming the Route 519 Athletic Fields the 'Oscar Unangst Memorial Fields'. This was approved on motion by Mr. Race, seconded by Mrs. Mackey with Mayor Herb abstaining. Herb – abstain, Mackey – yes, Race – yes.

Mr. Panetta also presented the idea of a memorial bench honoring a White Township teenager, Connor Barbero, who tragically passed away in an ATV accident. Connor enjoyed athletics, favoring basketball and soccer. Mr. Panetta suggested a bench representing those sports and Connor's jersey number. The committee approved this on motion by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable roll call vote. Herb – yes, Mackey – yes, Race – yes. Motion carried. The clerk will work with Mr. Panetta on both projects.

The outline of the steps involved in the preservation process prepared by The Land Conservancy of NJ was tabled for further review.

Committeeman Race recommended the township pursue preservation of the DeBoer farm. The farm is 56 acres that will go through a modified Muni-PIG application process. The town will apply and use its Muni-PIG SADC grant funding towards the project. The town will also pay its share of the acquisition costs. The county will cover all due diligence costs. This was approved on motion by Mr. Race, seconded by Mrs. Mackey with Mayor Herb abstaining. Herb – abstain, Mackey – yes, Race – yes. Motion carried.

NEW BUSINESS

Motion made by Mr. Race, seconded by Mrs. Mackey and carried by unanimous favorable roll call vote to authorize renewal of the Land Conservancy of NJ Open Space Advisory Contract for a one year period at \$100 per hour. The signing of the contract will be subject to Attorney Tipton's review and approval. Herb – yes, Mackey – yes, Race – yes. Motion carried.

Committeeman Race recommended approval for The Land Conservancy to propose the following contract to the Rothman's. The Rothman Farm, Block 33, Lot 20, consists of approximately 15.75 acres and Block 33, Lot 20.02 consisting of approximately 42.57 acres, for a total of approximately 58.32 acres (excluding exception areas). The contract calls for \$4,000/acre on approximately 48.32 or \$193,280.00 (prior to survey). White Township's share would be \$600/acre or approximately: \$28,992. This was approved on motion by Mr. Race, seconded by Mrs. Mackey

with Mr. Herb abstaining. Herb – abstain, Mackey – yes, Race – yes. Motion carried.
