## MINUTES OF MEETING APRIL 9, 2015

#### **CALL TO ORDER**

Mayor Holly Mackey called the meeting to order at 7:00 p.m. and stated 'Adequate Notice of this meeting of April 9, 2015 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times and Star-Gazette; and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

#### **FLAG SALUTE**

The Mayor asked everyone to stand for the flag salute.

#### ROLL CALL

Present: Mayor Mackey, Committeemen Herb and Race, Attorney Brian Tipton and Clerk Kathleen Reinalda.

#### **ENGINEERING UPDATE**

Paul Sterbenz was present to report on the following:

- Buckley Avenue DOT can close out the project once the following issues are addressed. Stone needs to be placed on various edges of the road, drainage inlets needs to be raised, and a damaged section of guiderail has to be fixed.
- DPW Generator Bids Bids were received on March 26<sup>th</sup>. Wire's Electric was the low bidder. A resolution awarding the bid is being presented for approval later in the agenda.
- Bonding requirements Mr. Sterbenz brought an issue to the committee's attention regarding a deviation from the ordinance requirements by the Zoning Board of Adjustment. A recent approval, Jack's Barn, the owners were asked to post a bond for landscaping improvements only, rather than for the entire project, as the code calls for. Mr. Sterbenz asked if the committee would like to continue this pattern for private sights in an effort to be more business friendly. The committee felt consistency should be followed with an upcoming approval for Trinacria, therefore, only a landscaping bond will be asked of the owner. In the future, private projects will be asked to post landscaping (including related items) bonds, with a restoration guarantee and the appropriate inspection fees.

#### **2015 BUDGET INTRODUCTION**

Auditor John Mooney was present to introduce the 2015 Municipal Budget. The 2015 Municipal Budget is flat, no increase from 2014.

Motion made by Mr. Herb, seconded by Mr. Race and carried by unanimous favorable roll call vote to approve the following ordinance on first reading. Herb – yes, Mackey – yes, Race – yes. Motion carried.

## CALENDAR YEAR 2015 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40a:4-45.154)

**WHEREAS**, the Local Government Cap Law, N.J.S.A.40A:4-45.1 et. seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 1.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

**WHEREAS**, the Township Committee of the Township of White in the County of Warren finds it advisable and necessary to increase its CY 2015 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Township Committee hereby determines that a 2.0% increase in the budget for said year, amounting to \$28,098 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS**, the Mayor and Township Committee hereby determine that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of White, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2015 budget year, the final appropriations of the Township of White shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$49,172 and that the CY 2015 municipal budget for the Township of White be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Motion to introduce the 2015 Municipal Budget made by Mr. Race, seconded by Mr. Herb and carried by unanimous favorable vote. Herb – yes, Mackey – yes, Race – yes. A complete copy of the 2015 Municipal Budget is on file in the office of the municipal clerk. Public Hearing is scheduled for May 14<sup>th</sup> at 7PM.

## **RESOLUTION #2015-30**

WHEREAS, NJSA 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, The Annual Report of Audit for the year 2014 has been filed by a Registered Municipal Accountant with the Municipal Clerk, as per the requirements of NJSA 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs: and

WHEREAS, The Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations"; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations" as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S.52:27BB-52 - to wit:

R.S.52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars(\$1,000.00), or imprisoned for not more than one year, or both, in addition

shall forfeit his office."

NOW, THEREFORE BE IT RESOLVED, that the Governing Body of the Township of White, hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this Resolution and the required affidavit to said Board to show evidence of said compliance.

#### **OLD BUSINESS**

Mr. Race continues to work on comments similar to the County's comments regarding the Highlands Regional Master Plan. The comment period has been extended to April 30<sup>th</sup>.

Motion made by Mr. Herb, seconded by Mr. Race and carried by unanimous favorable roll call vote to approve the 'Memorandum of Understanding' with the American Red Cross. The memorandum clarifies both party's obligations during times of disaster. The memorandum does not obligate any funding by either party. Herb – yes, Mackey – yes, Race – yes. Motion carried. The Memorandum is on file in the office of the municipal clerk.

Attorney Tipton continues to work with Belvidere's counsel regarding the Inter-Local Sewer Agreement. The 'Belstra Agreement' requires a discharge which Attorney Tipton must file with the County after approval by Linda Belstra. The fees owed by White Township for 2014 flow continue to be calculated by Belvidere.

#### **NEW BUSINESS**

The official CMV for Twin Brook Farm (Shoemaker) has come in at \$6,600/acre for 21.76 acres. The Land Conservancy is seeking permission to offer the landowner this value for the development rights. Motion was made by Mr. Race, seconded by Mr. Herb and carried by unanimous favorable roll call vote to authorize The Land Conservancy of NJ to offer Mr. Shoemaker this value. Herb – yes, Mackey – yes, Race – yes. Motion carried. The committee requested Mr. Tipton research how 'availability of funding' language can be added to each development easement offer so as to assure that the township has enough in its Open Space Trust Account to enter into contracts.

The clerk is meeting with locksmiths to gather information on the township's options for a secure lock system at the recreation building.

Motion to approve the Trinacria LLC Developer's Agreement made by Mr. Race, seconded by Mr. Herb and carried by unanimous favorable roll call vote. Herb – yes, Mackey – yes, Race – yes. Motion carried.
