2016 BUDGET ADOPTION

COLA ORDINANCE: Motion to open the Public Hearing made by Mrs. Mackey, seconded by Mr. Race. Being no comments, motion to close the Public Hearing made by Mrs. Mackey, seconded by Mr. Race. Motion to adopt the COLA Ordinance made by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable roll call vote. Herb – absent, Mackey – yes, Race – yes. Motion carried.

CALENDAR YEAR 2016 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40a:4-45.154)

WHEREAS, the Local Government Cap Law, N.J.S.A.40A:4-45.1 et. seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 0.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee of the Township of White in the County of

Warren finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$47,429 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Township Committee hereby determine that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of White, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Township of White shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$47,429 and that the CY 2016 municipal budget for the Township of White be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

BUDGET ADOPTION: Motion to open the Public Hearing made by Mrs. Mackey, seconded by Mr. Race. Being no comments, motion to close the Public Hearing made by Mrs. Mackey, seconded by Mr. Race. Motion to adopt the 2016 Municipal Budget made by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable roll call vote. Herb – absent, Mackey – yes, Race – yes. Motion carried. A complete copy of the 2016 Municipal Budget is on file in the Municipal Clerk's office.

Specifically, that the "present and prospective fair share of the housing need in a given region....shall be computed for a 10 year period". Motion made by Mrs. Mackey, seconded by Mr. Race and carried by unanimous favorable roll call vote to hire Jamie McDermid as a Tax Clerk at \$10 per hour with a maximum of 15 hours per week; no benefits provided.
