2018 MUNICIPAL BUDGET ADOPTION

CALENDAR YEAR 2018 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by

ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of White in the County of Warren finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$49,418 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of White, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Township of White shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$49,418 and that the CY 2018 municipal budget for the Township of White be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

The 2018 Budget includes a 2 cent increase making the municipal levy a total of seven (7) cents. This is an approximate \$56 annual increase to a home assessed at \$258,674.00. ORDINANCE AMENDING ARTICLE XX OF THE LAND USE ORDINANCE ENTITLED "N-C NEIGHBORHOOD COMMERCIAL DISTRICT" TO ALLOW MEDICAL AND HEALTH SERVICE USES AS PRIMARY INTENDED USES IN THE N-C NEIGHBORHOOD COMMERCIAL DISTRICT

WHEREAS, a variety of retail and office uses are permitted in the Township's N-C Neighborhood Commercial District ("N-C"); and

WHEREAS, the primary intended uses in the N-C District are enumerated in Section 160-160 of the Land Use Ordinance; and

WHEREAS, the list of primary intended uses does not include medical and health service uses; and

WHERAS, medical and health service uses would typically be a primary intended use in a zone such as the Township's N-C District; and

WHEREAS, the Township would like to amend the Land Use Ordinance to allow medical and health service uses as primary intended uses in the N-C District.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of White as follows:

- <u>Section 1</u> Section 160-160A of the Code of the Township of White shall be amended to add the following:
- (13) Medical and health services, excluding veterinarian services.
- <u>Section 2</u> Portions of the Code not set forth above shall remain unchanged.
- <u>Section 3</u> This ordinance shall take effect upon adoption by the Township Committee in accordance with the law,
- $\underline{\text{Section 4}}$ Any section, subsection or portion of this ordinance that may be found to be invalid by a competent court of jurisdiction shall not invalidate any other section, subsection or portion of this ordinance.

AN ORDINANCE APPROPRIATING THE SUM OF \$85,000.00 FROM THE CAPITAL IMPROVEMENT FUND OF THE GENERAL CAPITAL ACCOUNT IN CONNECTION WITH THE COSTS ATTRIBUTABLE TO THE RUTHERFORD DRIVE IMPROVEMENT PROJECT

WHEREAS, the Committee of the Township of White, County of Warren, State of New Jersey, has determined that it needs to appropriate the sum of \$85,000.00 from the Capital Improvement Fund – General Capital Account in conjunction with the Rutherford Drive Improvement Project; and

WHEREAS, the Committee has been approved for a \$125,000.00 grant from the State of New Jersey for such improvement project, which will be used in addition to the \$85,000.00 to fund the project.

NOW THEREFORE BE IT ORDAINED by the Township Committee of the

Township of White, County of Warren and State of New Jersey that:

- 1. There are funds available in the Capital Improvement Fund of the General Capital Account in the Municipal Budget of the Township of White for costs attributable to the paving projects.
- 2. There is hereby appropriated the sum of up to \$85,000.00 from the Capital Improvement Fund of the General Capital Account in the Municipal Budget of the Township of White for the aforementioned purpose.
- 3. There is no debt authorized by this Ordinance.
- 4. This Ordinance shall take effect upon passage following a public hearing to be conducted thereon and publication of notice of final passage with the requirements of law.

ORDINANCE AMENDING ARTICLE II TERMINOLOGY AND ARTICLE XII ZONING OF THE LAND USE ORDINANCE TO CLARIFY THE DEFINITION OF SIGN AREA

WHEREAS, there is currently an inconsistency in the definition of sign area in Article II and Article XII; and

WHEREAS, the Township would like to amend the Land Use Ordinance to clarify the definition of sign area.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township

of White as follows:

<u>Section 160-4</u> of the Code of the Township of White shall be amended to replace the definition of sign area with the following:

SIGN AREA

Sign area shall be calculated as the entire area within a continuous perimeter, enclosing the extreme limits of sign display, including any frame or border. Where there is no frame or border, including signs composed of individual letters, numerals, or other symbols or illustrations, the sign area shall be the sum of the area of the smallest geometric area encompassing all of said letters or symbols or illustrations. Sign area shall not be construed to include the supporting members of any sign which are used solely for such purpose.

<u>Section 160-86.B</u> of the Code of the Township of White shall be amended by replacing Subsection B in its entirety with the following:

B. Sign Area Measurement. See definition of Sign Area in Section 160-4.

OLD BUSINESS

A letter was received from the NJ Department of Transportation requesting additional paperwork regarding the township's request for improvements at the intersections of County Route 519 and State Route 46 and Upper Sarepta Road and State Route 46. The clerk provided the necessary paperwork.

Robert Lagonera, ACO, was present to discuss the proposed shared services agreement with Washington Township for maintenance of an ACO vehicle. Mr. Lagonera explained he uses the vehicle for all the township's he works for, thus Washington is looking for assistance maintaining the vehicle. The proposed fee for White Township is \$500 annual in addition to Mr. Lagoner's mileage. The committee felt that the \$500 was fair but would like additional discussion on the mileage. The clerk was asked to convey this information to Washington Township.
