MINUTES OF MEETING AUGUST 10, 2017

CALL TO ORDER

Mayor Race called the meeting to order at 7:00 p.m. and stated 'Adequate Notice of this meeting of August 10, 2017 has been given in accordance with the Open Public Meetings Act by forwarding a notice of the date, time, and location of the meeting to the Express-Times and Star-Gazette and by posting a copy thereof on the bulletin board in the Municipal Building and the township website. Formal action may be taken at this meeting. Public participation is encouraged. This agenda is subject to last minute additions and deletions by the White Township Committee'.

FLAG SALUTE

The Mayor asked everyone to stand for the flag salute.

PUBLIC COMMENTS

Warren County Sheriff, James McDonald Sr. presented Project Lifesaver. The primary mission of Project Lifesaver is to provide timely response to save lives and reduce potential injury for adults and children who wander due to alzheimers, autism, and other related conditions or disorders. The (PAL) Protect and Locate units that are utilized for this program range in cost from \$650.00 to \$800.00. Mr. McDonald requested the committee consider a donation towards this program. Motion made by Mrs. Mackey, seconded by Mr. Herb and carried by unanimous favorable roll call vote to authorize funding for (3) three units. Mr. Herb – yes, Mrs. Mackey – yes, Mayor Race – yes. RESOLUTION OF THE TOWNSHIP OF WHITE APPROVING THE PROPOSED SETTLEMENT BETWEEN THE TOWNSHIP OF WHITE AND BRYAN LEH AND FRANCIS LEH

WHEREAS, Bryan and Frances Leh (hereinafter collectively "Leh"), residing at and joint owners of 41 Tamarack Rd. Belvidere, New Jersey 07823, designated on the official tax map of White Township, Warren County, New Jersey as Block 69, Lot 24.22 (hereinafter "the Property") alleged that the Property has been and is being damaged by runoff of surface water from lands located across Tamarack Road; and

WHEREAS, Leh has alleged that the damage to the Property was caused by the improper design of a driveway approved by the Township of White (hereinafter "Township"); and

WHEREAS, the Township and Leh have agreed to amicably resolve this dispute concerning the alleged damage to the Property, whereby the Township agreed to compensate Leh for a total amount of \$8,000.00 in consideration for Leh's settlement and release of any past, present, and/or future claims Leh may have in relation to the damage to the Property; and

WHEREAS, the terms of the release and settlement agreement between the Township and Leh are contained in a certain Settlement and Release Agreement; and

WHEREAS, the Settlement and Release Agreement between the Township and Leh is specifically entered into without the admission of liability by either the Township or Leh.

NOW, THEREFORE, BE IT RESOLVED by the Township as follows:

- 1. The Township hereby approves the Settlement and Release Agreement to resolve and release any and all outstanding claims in relation to this matter involving the alleged damage to the Property by the surface water runoff for the total amount of \$8000.00; and
- 2. Pursuant to this approval, the Township Mayor and Township Clerk are authorized to execute the Settlement and Release Agreement.

ORDINANCE No. 2017-3

AN ORDINANCE AMENDING SECTION 160-121 ENTITLED "ECHO HOUSING UNITS" OF THE CODE OF THE TOWNSHIP OF WHITE

WHEREAS, Elder Cottage Housing Opportunities ("ECHO") units are small, removable modular cottages put on a concrete slab or treated wood foundation in a back or side yard of a home; and

WHEREAS, these units are specifically designed to permit seniors or people with disabilities to live independently, but close to family members and care givers; and

WHEREAS, Section 160-121 of the Code of the Township of White ("Township Code") permits ECHO units as conditional uses on property improved with a single-family residential home; and

WHEREAS, previously ECHO units were managed and provided for through a variety of government programs and Section 160-121 of the Township Code required that ECHO units be owned or provided by a government agency; and

WHEREAS, currently there are no government programs operating in Warren County providing ECHO units, therefore, it is impossible for residents to comply with all conditions of Section 160-121 of the Township Code; and

WHEREAS, the Township Planning Board recognizes the importance of allowing residents to provide ECHO housing to elderly or disabled family members and recommends that the Township continue to allow the placement of ECHO units despite the termination of government programs supporting ECHO units; and

WHEREAS, the Township Committee agrees with the recommendation of the Planning Board and desires to amend its ordinances accordingly.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of White that Section 160-121 entitled "ECHO Housing Units" of the Code of the Township of White ("Code") is hereby amended, in part, as follows:

<u>Section 1.</u> Delete subsection (f) in its entirety. The remaining subsections in Section 160-121 shall be re-lettered accordingly.

Section 2. Portions of the Code not set forth above shall remain unchanged:

<u>Section 3.</u> This ordinance shall take effect upon adoption by the Township Committee in accordance with the law.

<u>Section 4.</u> Any section, subsection or portion of this ordinance that may be found to be invalid by a competent court of jurisdiction shall not invalidate any other section, subsection or portion of this ordinance.

OLD BUSINESS

The committee reviewed the 2014 Master Plan Re-Examination Report Recommendations. Specifically, the recommendation suggesting the re-zoning of a portion of Titman Road from commercial to residential. The committee is in receipt of the Planning Board's continued support for the change, therefore, Attorney Tipton was asked to prepare the ordinance for first reading for the September 14th meeting.

The Zoning Officer recommended the township amend section 160-107A(2) to be in accordance with the Uniform Construction Code (U.C.C). Section 160-107A(2) currently states that any fence in excess of 48 inches in height shall require a building permit. The U.C.C. does not require permits for fences six feet or less. Motion made by Mrs. Mackey, seconded by Mr. Herb with Mayor Race opposed to authorize Attorney Tipton to prepare an ordinance for first reading on September 14th. Herb – yes, Mackey – yes, Race –no. Motion carried.
