## Minutes Open Session White Township Zoning Board of Adjustment February 16, 2012

There was a regular meeting of the White Township Zoning Board of Adjustment on Thursday, February 16, 2012. Present were Board Members: Kyle Shoemaker, James Cooper, Elaine Reichart, Donald Weidlick, Paul Mourry, Myron Rasley, Barry Wessner, and Joseph Magnini. Absent: Kyle Shoemaker. Also Present: Board Attorney William Gold and Board Secretary Alfia Schemm. Chairman Magnini led the Board in the pledge to the flag and he called the meeting to order at 7:35 p.m. He announced that notice of this meeting was given in compliance with the "Open Public Meetings Act."

#### **OPEN TO THE PUBLIC**

Chairman Magnini opened the meeting to the public for non-agenda items. With there being no public comment, the meeting was closed to the public.

#### **NEW BUSINESS:**

## #453 Dennis Chamberlain, 662 Brass Castle Road, Block 16, Lot 15

Dennis Chamberlain was sworn in and he testified to his application for an accessory building, which already exists. Mr. Wessner stated that he visited the site and he takes no exception to the Applicant's request. Chairman Magnini stated that he also drove to the site, but he did not walk the property. The Board continued to review the proposal.

Ms. Reichart made the motion to grant the variance. Motion seconded by Mr. Rasely. In a voice vote, all were in favor.

### **MEMORIALIZING RESOLUTION:**

### #452 SAMA Properties, 188 CR 620, Block 28, Lot 2

Mr. Cooper made the motion to adopt the Resolution. Ms. Reichart stated her concern over the Resolution, stating that there is too much detail/information in the Resolution, which she feels is not relevant and inappropriate. She stated that only the present protected non-conforming items/uses should be addressed in the Resolution. The Board discussed the application that was presented and their action and the possible future changes to the Ordinances.

Ms. Reichart stated that she would like to amend the Resolution to delete the reference to the photographs in the Resolution and to only focus on the uses/items are not allowed/permitted in the Industrial Zone as of today. With there being no second the motion dies.

Chairman Magnini seconded Mr. Cooper's original motion. In a voice vote, all were in favor, except Ms. Reichart, who voted in opposition and Mr. Mourry and Mr. Rasely, who abstained as they were not present at the February meeting.

Mr. Cooper made the motion to adopt the Report with Ms. Reichart's recommendation. Motion seconded by Mr. Mourry. Discussion on the motion: The Board discussed the process. In a voice vote, all were in favor, except for Mr., who abstained.
