# Minutes Open Session White Township Zoning Board of Adjustment August 15, 2013

There was a regular meeting of the White Township Zoning Board of Adjustment on Thursday, August 15, 2013. Present were Board Members: Donald Weidlick, Barry Wessner Alt #1, Myron Rasley, Joseph Magnini, Vincent Iacampo Alt #2, Jim Cooper, and Paul Mourry. Board Members Absent: Kyle Shoemaker and Elaine Reichart. Also Present: Board Attorney William Gold and Board Secretary Alfia Schemm. Chairman Magnini led the Board in the pledge to the flag and he called the meeting to order. He then announced that notice of this meeting was given in compliance with the "Open Public Meetings Act."

### **OPEN TO THE PUBLIC:**

Chairman Magnini opened the meeting to the public. With there being no public comment the meeting was closed to the public.

#### **NEW BUSINESS:**

## #455 Darnette Vickers, Block 66, Lot 21

Darnette Laverne Vickers was sworn in and she testified that she wants to purchase a Recreational Vehicle and she wishes to build a building that would store the vehicle. The following was marked as an Exhibit:
