### MINUTES OCTOBER 11, 2016

### **NEW BUSINESS:**

### #779 Flowerland Growers, Block 63, Lot 3-Minor Site Plan/Variances

Dominick Santini, Esq. was present on behalf of the Applicant and he gave a brief overview of the proposal. Board Attorney Dieterly reviewed case law in regards to Township Officials providing expert testimony, which he stated is not applicable in this matter.

Bryan VandeVrede was sworn in and he provided testimony in regards to the proposed additional greenhouse and two water tanks, which was discussed with the Board.

Jess Symonds was sworn in as an Engineer. He stated that they have no concerns in regards to complying with the Board Professionals. He reviewed the proposal, which was discussed with the Board. He stated that he does not see any detriment in the granting of the variances.

Attorney Santini summarized the farming operation and he asked that the Board grant the variances and approve the site plan. Board Attorney Dieterly stated that he has reviewed the language in the notice and has found it to be satisfactory.

Mr. Mackey made the motion to grant the two variances. Motion seconded by Mr. Pritchard. In a voice vote, all were in favor.
