# WHITE TOWNSHIP PLANNING BOARD MINUTES NOVEMBER 14, 2017

The regular meeting of the White Township Planning Board was held on Tuesday, November 14, 2017. Present were: Joseph Phillips, Timothy Matthews, Drew Kiszonak, Robert Mackey, and Michael Grossmann. Board Members Absent: Jeff Herb, Bryan Vande Vrede, David Pritchard and Sam Race. Also present: Attorney Dan Makoski and Board Engineer Paul Sterbenz.

#### **CALL TO ORDER:**

Chairman Timothy Matthews called the meeting to order at 7:35 p.m. He stated that the meeting is being held in accordance with the "Open Public Meetings Act", with adequate notice to the appropriate newspapers and posting on the Township bulletin board.

#### **OPEN TO THE PUBLIC:**

Chairman Matthews opened the meeting to the public for non-agenda items.

A Resident of Spring Lane was present and he addressed the drainage and runoff on the Lane. He distributed some photographs and he stated that he knows that the Township is aware of the situation as he has spoken to both the Mayor and the Township Engineer. The issue was discussed and it was suggested that the matter be brought up at a Township Committee meeting.

Craig Spencer was present and he stated that they are proposing the installation of an ECHO unit. He stated that an approved new septic system has been installed. He went on to review the conditions of the new Conditional Use Ordinance. Board Engineer Sterbenz also reviewed the proposal. The Board discussed the enforcement/tracking process and an annual verification that the Occupant continues to reside in the Unit.

Mr. Grossmann made the motion to grant the approval as discussed this evening. Motion seconded by Dr. Phillips. Discussion on the motion: Board Engineer Sterbenz reviewed the granting approval to be: Approval of a Conditional Use Permit and Minor Site Plan, subject to the annual verification process. A waiver of the Grading Plan was also suggested. In a voice vote, all were in favor.
